**II. Campus Reports and Responses**

**a. President Report – Doug Carroll**

Doug Carroll reported on Curators Breakfast, Competitive Salaries and the “Campus Carry” amendment in House Bill HB668.

The following resolution was **passed** (1 abstain)

*FS0809res-3*

*Whereas, the Missouri House of Representatives passed an amendment to HB668 allowing "campus carry", and*

*Whereas, concealed weapons represent a danger to the campus community,*

*Be it resolved that the Faculty Senate of Missouri S&T support the April 6, 2009 statement of President Gary Forsee and join with him to oppose this action.*

**b. Administrative Report – Chancellor John F. Carney III**

Chancellor Carney spoke on Access Missouri. The state gives almost \$100M in need based aid every year. More than half that goes to students enrolled in private institutions, who make up roughly one third of the Missouri students receiving need based aid. This is a clear indication of the low level of state support for public higher education. Chancellor Carney testified in favor of \$700M in capital projects and there is also some federal stimulus money that might be available for capital projects. Chancellor Carney does not believe that the “campus carry” law will pass in the Senate. The Curators and Trustees were together on campus April 2 and April 3, 2009. The Curators voted not to raise tuition next year as long as the state budget provided the same funding for the University of Missouri as in FY 2009. Toomey Hall dedication will be on April 17<sup>th</sup> at 1:30 PM and the Toomey extended family will be on campus for the event. S&T alumnus and National Academy of Engineering inductee George Stegemeier will be on Campus April 21<sup>st</sup> to give a seminar on Solar Warming from 3:30-4:00 PM in 204 McNutt Hall. All are encouraged to attend.

**c. Administrative Report – Provost Wray**

Provost Wray gave reports on the offices of Academic Affairs, Undergraduate Studies, Global Learning and Sponsored Programs.
