**II. Campus Reports and Responses**

**a. President Report – Michael Schulz**

The Board of Curators will be on the S&T campus April 15-16, 2010. Faculty Senate will host a luncheon at noon on Thursday instead of a Friday morning breakfast as has been the custom. Jerri Arnold-Cook will give a presentation on “Student Leadership Development”.

President Schulz reported on Budget, Benefits Survey, Bylaws, Minor Degree for Students in Corporate Engineering Program at MSU, and the possibility of an Employee +1 benefit.

**b. Administrative Report – Chancellor John F. Carney III**

The legislature is considering the Access Missouri question again this year. Approximately \$900 million in financial aid is provided to Missouri high school graduates if they attend Missouri institutions of higher learning. The current legislation gives more than twice as much financial aid to a high school graduate if they choose to go to a private university rather than a public university. The

Coordinating Board, who deals with tuition issues, took action last week and voted 5 to 1 with 2 absences to oppose the legislation that would equalize the awards.

President Forsee will be on campus Friday, February 19 and Saturday he will accept the “Man of the Year” award from his fraternity.

There will be a special General Faculty meeting March 1, 2010 to vote on an honorary degree candidate.

A donation from Fred and June Kummer will provide the needed additional funding (\$1.25M) to complete the Student Design Center project. This will include some commercial space by Bishop Avenue and take care of the maintenance of the facility once it is built.

**c. Administrative Report – Provost Wray**

Provost Wray gave reports on the offices of Academic Affairs, Enrollment Management, Global Studies, Graduate Studies, International Affairs, Sponsored Programs and Undergraduate Studies.
