**b. Administrative Report – Chancellor John F. Carney III**

Chancellor Carney was in Jefferson City on February 18<sup>th</sup> and spoke with Governor Nixon. The chancellor felt the governor understands the importance of public higher education. President Forsee will be on campus Friday, March 6<sup>th</sup>. Chancellor Carney encourages everyone to attend the special FS meeting on February 24<sup>th</sup> with Betsy Rodriguez. The Career Fair was Tuesday, February 17<sup>th</sup>. There were 149 companies on campus and 400 recruiters from 25 states. The HLC Accreditation Team will be on campus February 22<sup>nd</sup>, 23<sup>rd</sup> and 24<sup>th</sup>. Our Mission Statement is: *Missouri University of Science and Technology integrates education and research to create and convey knowledge to solve problems for our State and the technological world.* The Board of Curators and Missouri S&T Trustees will be on campus April 2<sup>nd</sup> and 3<sup>rd</sup>.
