A motion to accept the revised Promotion and/or Tenure Procedures for Tenure-track and Tenured Faculty **passed** unanimously with a friendly amendment to add “of the campus review committee” qualifying “member” in section II.B.4c, which, with the amendment, will read “Any new information deemed appropriate by any member **of the campus review committee** for possible inclusion in the dossier after the dossier has left the department but before the campus review committee has sent its report to the Provost shall be submitted for consideration to the entire campus review committee.”
