*Whereas Missouri S&T cannot survive as a quality technological research university with the continuation of across the board budget cuts adjusted for productivity measures, the Missouri S&T Faculty Senate urges the administration to: 1) prioritize the functions and entities that support the mission of the campus; 2) implement a targeted budget reduction process in line with the established priorities.*
