**Minutes of the Academic Council Meeting**  
**November 15, 2007**

**I. Call to Order, Roll, and Approval of Minutes**

The meeting was called to order at 13:30 by President Frank Blum and roll was taken. The following absentees were noted: Stanley Woronick, Richard Hall, Ralph Wilkerson, Donald Wunsch, Mohamed Abdelsalam, Bill DeMalade, Paul Worsey, Gary Mueller.

The meeting minutes of October 18, 2007 were **approved** as submitted.

**II. Campus Reports and Responses**

**a. President Report – Frank Blum**

This month's Academic Council meeting may be its last. If the Board of Curators approves the revised Faculty Bylaws, the name of the governing body will be changed to Faculty Senate for the next meeting.

The Board of Curators will meet November 29-30 in Kansas City, and will consider a number of changes to the Collected Rules and Regulations related to the responsibilities of Deans, Schools and Colleges. The changes are necessary for UMR/MST to fully implement its management structure which has no Schools and Colleges.

At the Intercampus Faculty Council (IFC) meeting this month, Vice President Krawitz gave a presentation on the 2008 budget. The UM System is developing the process for implementing Senate Bill 389. There is a new health benefits plan that will increase medical leave opportunities for some of the non-regular faculty. There will be no increase in benefits cost for this year, and a 6% reduction in dental costs.
