b. Administrative Report – Provost Wray for Chancellor John F. Carney III

Higher Education will be protected by Governor Nixon and we are not expecting a withholding this year however state revenues were down 11% at the end of September compared to the projected number.

The Show-Me solar house team is in Washington, DC and the judging competition is in progress. Twenty houses were invited to this international competition with Missouri S&T being selected to its 4th competition, one of only two such schools.

Tours of the campus will be given on Friday to visitors from Fort Leonard Wood including Major General Martin. The purpose of the visit is to find out what we can do to help one another such as research needs and opportunities.

Computer Science has their ABET visit on Sunday, Monday, and Tuesday.

III. Reports of Standing and Special Committees

a. RP&A – Greg Gelles

Greg Gelles gave a report regarding the on-going process of changes in the Acceptable Use Policy.

RP&A made the following motion: The Curators have recently adopted changes to the Collected Rules and Regulations Acceptable Use Policy. The Missouri S&T Faculty Senate has in the past empowered the Information Technology and Computing Committee (ITCC) to address these revisions to Acceptable Use Policy and monitor the Designated Approving Authority (the internal security policies) at Missouri S&T. Given the recently adopted changes to the Collected Rules, the RP&A committee moves that the Faculty Senate empower the ITCC to continue monitoring our existing security

procedures as to: Do the procedures work; are the procedures being followed; and report to the Faculty Senate any problems or suggestions for improvement. The motion passed unanimously.

b. Curricula Committee – Keith Nisbett

The Missouri S&T Campus Curricula Committee recommend that the curriculum changes and degree proposals be approved. No major disagreements were found. There were 3 Degree Change (DC), 26 Course Change (CC) and 15 Experimental Course (EC) forms.
