**II. Bylaw Amendment**

Twenty-five members of the Faculty Senate are required to have a quorum to do business. The count did not meet the minimum number of representatives needed for a quorum.

Dr. Fitch stated that the Body could still abide by the Collected Rules and Regulations, but not as the Faculty Senate.

He made note of applicable CRR 300.030.G:

Amending the Bylaws – Amendments may be proposed by twenty (20) faculty members of the General Faculty by submitting them to the Rules, Procedures, and Agenda Committee.

The Faculty Senate does not have any official role in that process. Without a quorum this will just be a meeting of some faculty. The present Body may act as those twenty faculty members to propose changes to the Bylaws.

After some discussion, a motion was made for adjournment. Dr. Fitch pronounced this a quorum call and adjourned the meeting.
